From Your President

As 2008 comes to an end, the Guild has many accomplishments to reflect on. Members hosted the second annual HeART of Oregon Show and Museum Fundraiser which brought in an estimated 800 visitors to the museum and art event. It assisted the museum in raising over \$1300 from the silent auction which helps to fund programs. Guild members participated in the Open Studio Tours of Beavercreek, one in June and another just a few weeks ago in October. The turnout for the October studio tour was much better due to the beautiful sunny autumn weather. There were quite a few return visitors as well as newcomers. We all want to thank the coordinators of this great event! Each year it becomes bigger and better with the addition of exciting new artists. I predict someday the Open Studio Tours of Beavercreek will become as well know-no better known-than the Portland tours and there is no charge to visitors.

Our membership has grown to 90 strong in 2008 and although not everyone is able to make the meetings, we still have a good turnout of between 35 to 50 members. The board has also grown this past year to include a guild historian, membership coordinator, volunteer coordinator and newsletter editor. Mary McCarty stepped forward to take on a second hat of the guild librarian at our last meeting. We still need several people to step into the positions of advertising coordinator and the website coordinator-two very important positions at this point in our growth.

We were asked to install art in the city of Oregon City planning department at 221 Molalla. The artists have been chosen for the first installation but we had a small set-back in locating the installation systems. This project is once again moving forward and projections for a December installation are in the works. The guild is moving into its second year at the End of the Trail Gallery. Glenda and Jodi have done a wonderful job keeping the artwork fresh and the installations professional. We all need to remember the gallery when we are shopping for that special gift during the holidays.

The November meeting will be the last of the year due to the Holiday show at the Pioneer Center. I would like to thank the committee members for helping to coordinate our first Holiday event in partnership with the Pioneer Center.

In January, I look forward to handing over the President's position to Anne Paris. She has proven to have strong leadership qualities and great ideas for involving members in the programming of the 2009 meetings. We will be reviewing your recommendations at a special meeting in late November to prioritize your suggestions.

Although I will be stepping away from the President's position, I will still be representing this body for at least 3 years as a board member on the Main Street Oregon City Committee. On September 26, 2008, Oregon City was selected to participate in the Performing Main Street Program. Acceptance into this program will allow our community to participate in training, community assessments, technical assistance, national recognition and future grant programs. One of my visions for the future of our Main Street is to see a transformation though the arts community with public art programs, art in businesses, more art galleries and downtown studio tours. I will also participate in the Oregon City Chamber of Commerce as a member of the Government and Economic Affairs Committee to insure the idea that a strong arts community is also a sign of a strong economic community. We are artists and business people who have a big impact on the economy of our community! Okay, I'll get off my soapbox and stop sounding like a politician!

In closing, I would like to wish everyone a very Happy, Healthy Holiday Season!

Anne Paris made motion to approve the September minutes with additions above and Paula Lewis seconded. Motion passed unanimously.

Treasurer's Report. Glenda reported a balance of \$2,730.84. She also reported that the annual liability insurance premium is due.

New Business. It was requested by Linda Spillum that the actual street address of the Pioneer Center regular meetings of 615 5TH Street be listed in the newsletter, headliner and other published information.

HeART of Oregon. Lynda reported that it will be included in the 150 Things to Do in Oregon City advertisement. Due to scheduling conflicts with the Clackamas County Museum the usual date is not available. At this time it looks like the show date will be a weekend in March.

Due to the Holiday Show being held on the first weekend in December, it was suggested that **no meeting would be held in December.** Mindy Benfield made the motion to cancel December's meeting, Paula Lewis second. Motion passed.

North Clackamas Art Show. It was reported by Mary McCarty that the show had over 300 entries. Lots of entries good and high quality. She also said the arrangement of the show/sale was great.

It was reported that the **Holiday Show** is listed in Saturday's Oregonian *How We Live* Section.

Membership Dues. Question was raised if we are aggressively tracking Membership Dues. If members aren't renewing, find out why and if the former members have any suggestions for us. Oregon City Selected for New “Main Street” Program

Update. We had our monthly meeting this week and several issues came up that could affect guild artists. First, the program will be putting out a call for artists for a logo to give it a marketing identity. This is still in the planning stage and a call is being drawn up and evaluated. Once the call to artists is finalized I will be sending it out to the Guild members.

One thing I think everyone notices about our downtown is the empty windows of businesses that have closed their doors. Other downtowns have utilized these empty store fronts as art galleries. With the installation of art in the windows, it gives the effect of the buildings being an integral part of the downtown and actually helps to bring new businesses into the area. In 2009, the committee will be hiring a Downtown Manager to work with downtown businesses and identify deficiencies in existing retail. They will also be working to help transform the downtown and help bring people down there for events and incorporate more art, street design, clean ups and plantings.

These are just a few of the opportunities that will be coming forward for our community artists.

New Home for HeART of Oregon

The HeART of Oregon is unable to use the facilities at the Museum of the Oregon Territory. We are no longer able to participate in the fund-raiser for the museum without paying for the space. The amount necessary for the rental is out of our budget range so we are looking to partner with a new entity for a fund-raiser and art show. At our last board meeting, it was suggested to bring the proposal to the Main Street Program which I did at their last board meeting. I am meeting with the Vice-president of the Main Street program who is also on the Promotions committee with me and the event coordinator for the Abernethy Center.

This year, the Guild is going to ask for a percentage of the Silent Auction totals to begin a scholarship fund. We have been discussing the fund but haven't been able to secure any money to begin investing. There are several other locations in Oregon City that we will be looking into if the Abernethy is unavailable. The HeART of Oregon has been a big success in the past and has gotten a good reputation in the community for being a classic event. The show will go on, it's just a question of where and when.

Open Studios of Beavercreek celebrated their fifth year of promoting local artists. We had 30 artists, located at 14 studios. We were pleased that most of the artists from our June Tour chose to join the October Tour. Some new artists joined us and added to our quality and diversity.

To celebrate our 5TH year, we gave away five \$50.00 gift certificates to be spent at any one of the participating artists. Our visitors needed to visit 7 of the 14 studios to qualify and did not seem to be a difficult task. They were quite excited.

We estimate 200–230 visitors. Friday was slow, which lead us to ponder!! But Saturday and Sunday proved to be terrific days for all. The weather was beautiful, aside from the wind. The visitors to our studios were so upbeat and positive about the quality of the art and the settings. They hung around, chatted, and bought. The artist's feedback regarding the tour, expressed their sales to be more than expected. We surprisingly still found people who live in Beavercreek, and had not heard of the past Tours.

It was a good weekend. The Open Studio planning committee works well together, and therefore, the Tour ran very smoothly. And now, we're on to June. Public Art Project

In January of 2008, the Clackamas County Board of Commissioners adopted the Public Art in Clackamas County Project Plan for 2007-2010 which describes the development process and importance of public art projects in various locations throughout the county. The 82nd Drive/Park Place pedestrian bridge is part of this plan. The bridge suffered from a fire in 2007 set by transients and is now in the process of reconstruction. A steering committee has been formed to begin a temporary public art project that will be on display between April and August of 2009. Its mission and purpose are to guide the development of the temporary artwork that will enhance the 82ND Drive/Park Place Pedestrian Bridge site, benefit the County citizens and bridge users, and ensure that aesthetic decisions are integrated and consistent with existing cultural values and principles. In December there should be an RFP out for artist review and submittal. I will definitely keep everyone updated regarding this project. There is a world of possibilities for potential pieces of art. The bridge should be reopened by the end of November. Those Guild artists interested in public art projects might want to get down and take a look.
